MEMORANDUM OF AGREEMENT

BY AND BETWEEN

Jewell County Sheriff's

AND

Harper County Communications

This Memorandum of Agreement (hereinafter "Agreement") is made and entered into on March 25, 2021, by and between **Jewell County Sheriff** (PSAP 1) and **Harper County Communications** (PSAP 2).

WHEREAS, the parties to the Agreement are participants in the Statewide NG9-1-1 System, and;

WHEREAS, the parties to this Agreement desire to provide contingency and/or overflow support to one another, and;

WHEREAS, the parties desire to formalize their decisions regarding said contingency and /or overflow support;

Jewell County Sheriff acknowledges that **Harper County Communications** will answer all calls presented to the extent that staffing and call volume allows. **Harper County Communications** does not represent that every call will be answered due to these limitations and Jewell County Sheriff acknowledges understanding that **Harper County Communications** overflow planning may be enacted and hereby agrees that Jewell County Sheriff calls may be overflowed according to those plans.

Jewell County Sheriff hereby authorized **Harper County Communications** to handle non-emergency calls received, where no response is necessary, pursuant to Harper County Policy and procedure and not deliver these types of calls back to Jewell County Sheriff. Harper County Communications will be the agency chosen as Jewell County's #2 backup.

This agreement may be terminated at any time by either party by written notice to the second party and shall remain in force until such time as it is so terminated.

IN WITNESS WHEREOF, the parties hereto agree to the terms of the Memorandum of Agreement.
